Once the plan deductible is met, the plan pays $100 \%$ of covered services for the rest of the calendar year. High-deductible Plan G does not cover the Medicare Part B deductible. However, high-deductible Plans F and G count your payment of the Medicare Part B deductible toward meeting the plan deductible. These expenses include the Medicare deductibles for Part A and Part B, but do not include the Plan's separate foreign travel emergency deductible.
${ }^{2}$ Plans K and L pay $100 \%$ of covered services for the rest of the calendar year once you meet the out-of-pocket yearly limit.

## POLICY REPLACEMENT
